I. The Mission of the Marine Patrol

Introduction

Patrolling the waters of Lake George since 1962, the Lake George Park Commission's Marine Patrol successfully completed 59 years of continuous service in 2021. Through the years, the Marine Patrol has built up a solid record of service dedicated to the protection of Lake George and its users.

The primary mission of the Marine Patrol is to promote the safe and enjoyable use of Lake George. The Marine Patrol accomplishes this primarily by protecting and educating the public. The Patrol also plays a key role in protecting the valuable natural resource of Lake George. The Marine Patrol provides a wide array of services to the boating public. These include assisting stranded boaters, emergency response and first aid, fire suppression, search and rescue, removal of hazards, recovery of lost property and boater safety training.

Additionally, the Marine Patrol enforces the New York State Navigation Law, Environmental Conservation Law, Lake George Park Commission Rules and Regulations, and all other laws.

The Patrol has a very large and diverse area to cover. At 32 miles long, Lake George presents these officers with over 50 square miles of patrol area, including 176 miles of shoreline and 170 islands. Lake George exists within many localities; three counties (Warren, Washington, and Essex), eight townships (Lake George, Bolton, Hague, Ticonderoga, Putnam, Dresden, Fort Ann, and Queensbury) and one village (Lake George) all of which touch the lake and have a vested interest in it.

The enforcement programs of the Commission are coordinated by the Director of Law Enforcement, a marine patrol lieutenant. This position allows the Director of Law Enforcement the opportunity to work closely with the patrol on a daily basis while maintaining consistent enforcement of the Commission's regulations throughout the Lake George Basin.

Patrol Operations

The Patrol season began on May 3rd and ran through October 31st. Beginning on July 1st the Marine Patrol operated at full strength, seven days a week until Labor Day. During the summer season six to seven patrol vessels were on duty Fridays, Saturdays, Sundays and holidays. A total of 6645 hrs. were logged by officers in 2021.

Equipment Upgrades

The Commission traded a 2012 21' Boston Whaler, on loan from NYS Parks and Recreation, in for a 2012 24' Boston Whaler. This 24' boat came to the Commission from another agency but only had 400 hrs. on it. The 21' traded back to NYS Parks had over 3600 hrs. on the hull. The Lake George Park Commission would like to thank NYS Parks and Recreation for their continued support in helping update our fleet of patrol boats.

II. Law Enforcement and Public Safety

The Lake George Park Commission continued to work on public safety this year. The Patrol again partnered with the local marinas to improve boater safety. The marinas continue to show the rental boat safety video to all customers who rent boats.

Vessel Sanitary Inspections

Due to the COVID-19 epidemic, the Marine Patrol did not conduct sanitary inspections in 2021. As soon as it is safe for the officers to board vessels, this program will be restarted.

Sound Testing

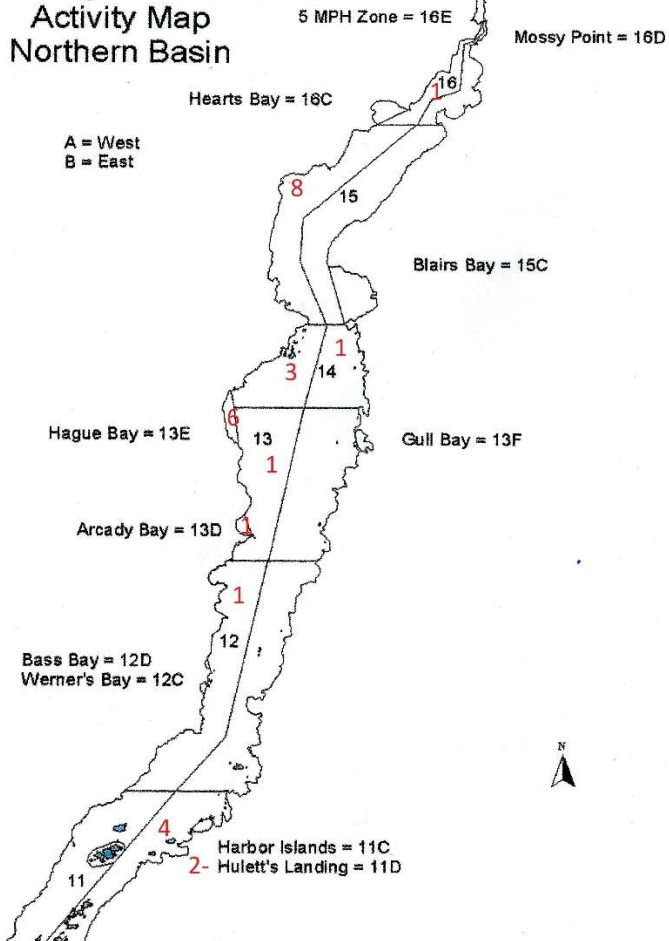
The Marine Patrol stepped up its noise tests on loud boats this year due to several complaints. Officer Ray VanAnden led the effort working alone and with other officers to quiet down the lake. A total of 14 noise tests were conducted in 2021. Of those 14 tests, 7 vessels passed and 7 failed. Those that were over the state's 90 decibel limit were ticketed and ordered from the lake until repairs were made.

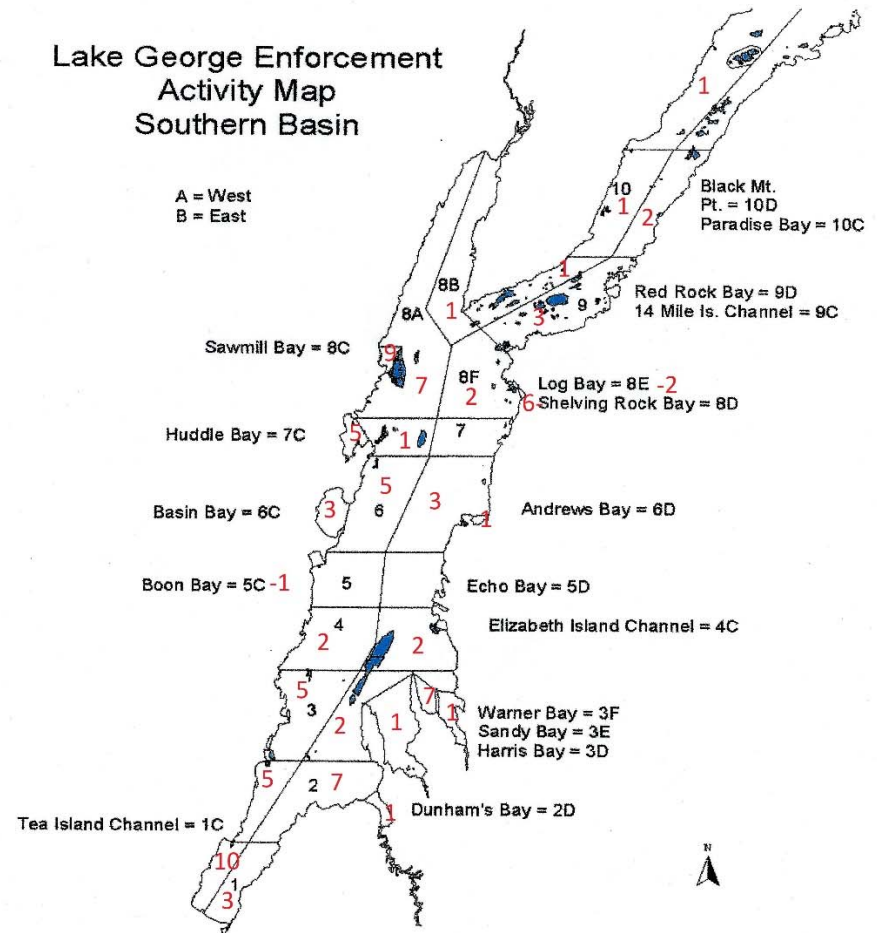

Lake George Enforcement Activity Map Northern Basin



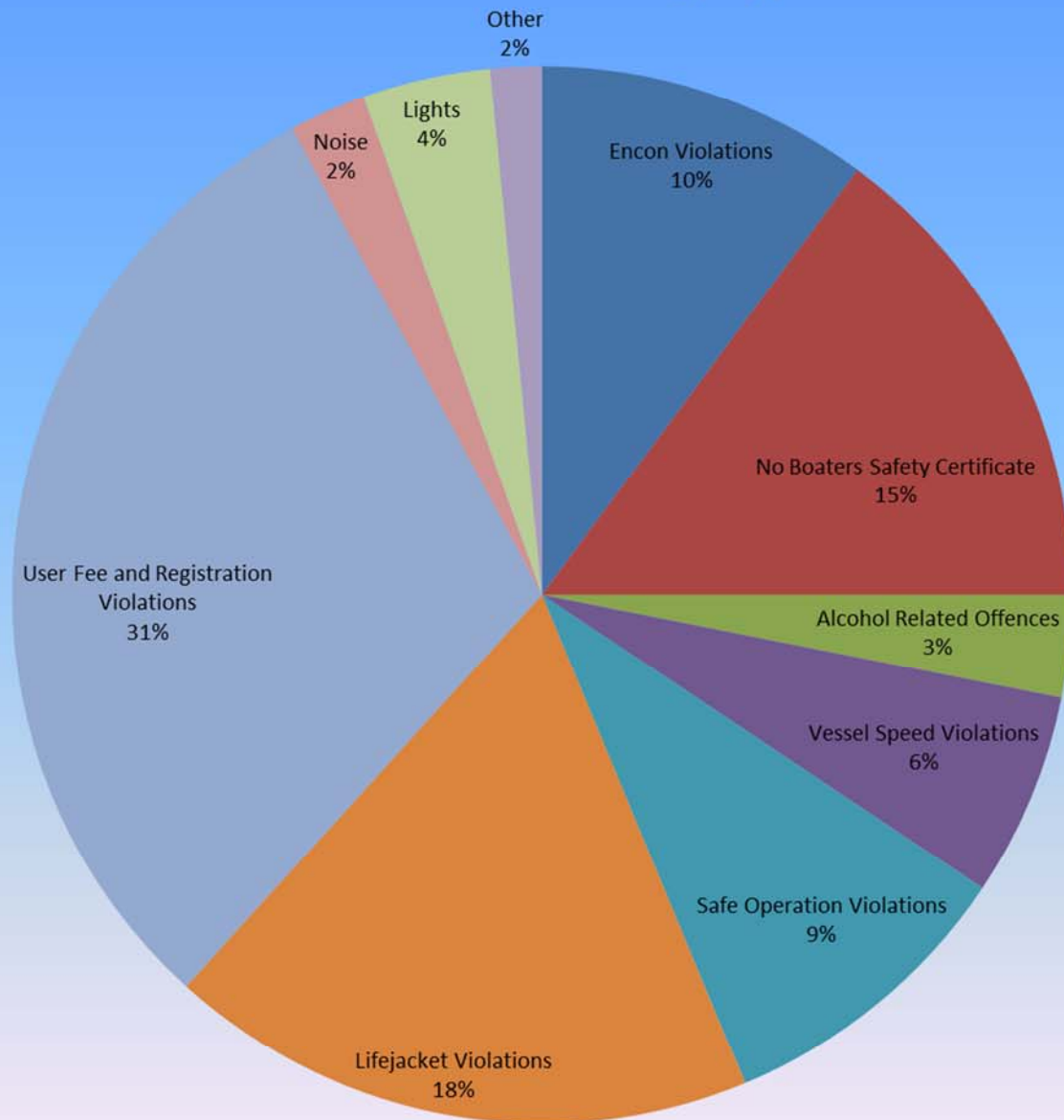
Lake George Enforcement Activity Map Southern Basin

Invasive Species



The Marine Patrol is actively engaged in the education of the boating public and enforcement of existing invasive species regulations. The marine patrol also inspected the unattended launches around the lake. The patrol's goal was to help educate the public about the inspection program as well as ensure that all vessels were properly inspected prior to launching into the waters of Lake George.

III. Public Assistance and Education

New York State Safe Boating Course Instruction

Brianna's Law: New York State has passed a new law which will require everyone who operates a boat to have a safety certificate by January 1, 2025. This law is being phased in as follows:

If you were born on or after:	You will need a boaters safety certificate when operating a motorized vessel during:
January 1, 1993	2020
January 1, 1988	2022
January 1, 1983	2023
January 1 1978	2024
All operators of motorized vessels, regardless of age, will need a boating safety certificate by January 1, 2025	

The Patrol currently has 9 Officers certified to teach boater safety classes in New York. There were 5 classes taught by members of the Patrol this year. Classes took place in Lake George,

Bolton Landing, Ticonderoga, Hudson Falls and South Glens Falls this year. If you have a group interested in hosting a class, feel free to give the Lake George Park Commission a call.

Recovered Property

The Marine Patrol recovered lost and or stolen property valued at more than \$72,784 during the 2021 season. Every year an assortment of missing vessels, canoes, and PWCs are routinely located by the patrol. In addition, a wide variety of smaller items such as knee boards, water skis, lifejackets and tubes are recovered. Any lake user who loses an item on or around the lake should check with the Patrol to see if the item has been found or turned in. At the end of each season, all recovered property is turned over to the Warren County Sheriff's Department.

V. Real Stories from the Marine Patrol

Unusual Incidents, Accidents and Rescues



Snowmobile Accident: Tragedy struck early this year on Lake George with a snowmobile accident on the afternoon of February 25th. At about 3:50 pm, police and fire were called to the docks at Halls Marina for a snowmobile accident with a man missing. When emergency personnel arrived, they found tracks on the ice coming from the north into an area of open water by the marina's docks. The victim apparently hit the dock and was ejected into open water. Dive teams from area fire departments arrived and were able to find the victim in about 12ft. of water. Life saving measures were immediately taken but the victim was not able to be saved. Lt. Johns responded to the scene and the Warren County Sheriff's Department conducted the investigation.

Sunken Boat: On the morning of Saturday May 1st, Lt. Johns was called to the scene of a sunken boat at a dock in Silver Bay. Upon arrival he found a 30' boat completely submerged and sitting on the bottom of the lake. It was reported that the vessel was afloat the previous night and must have gone down overnight. There was a small film on the water, so NYS Spills was called to respond. Booms and oil pads were deployed to contain and collect the residue. A commercial tow company arrived on scene to raise the boat.

Drowning: On Saturday June 12th just before 6 pm, Warren County Sheriff's patrols and Lake George EMS and Fire were dispatched to Shepards Park Beach for a possible drowning. Apparently, 3 men were swimming at the beach when one swimmer got in trouble and disappeared under the water. The other two men started calling for help. A bystander from Niskayuna ran into the water, dove down and immediately found the victim. She then pulled him to the surface and with the help of others, pulled the victim to shore. People on shore including Sheriff's (and Commission) Officer Gary Mazzacano worked on the victim administering CPR until EMS could arrive. The 65 yo victim from the Bronx was transported to Glens Falls Hospital. Unfortunately, he did not survive.

Assist other Agencies: The Lake George Park Commission Marine Patrol was asked to assist with patrolling Buffalo Harbor for an airshow featuring the Navy Blue Angels from June 16th to June 20th. Sgt. Paccione and Lt. Johns brought a patrol boat to Buffalo at the request of the US Air Force and NYS Police who were tasked with running the security for the event. Other agencies assisting were NYS Parks and Recreation, NYS Park Police, US Coast Guard, Buffalo Police, Tonawanda Police, NYS Police, DEC Police and other local police and fire departments from the area. All boats had to be kept clear from the area under which the aircraft were

performing. The Lake George Marine Patrol is becoming more well-known statewide and being called upon for assistance around the state.

Medical Assist: On Monday June 28th at about 1:50 pm, patrols were dispatched to Picnic Island for a 15 yo who fell on the wet rocks. The victim obtained a laceration to the back of his head during the fall. The victim was bandaged on the island and transported to an ambulance by Sgt. Paccione because no fireboat was available.

Vessel Fire: On Friday July 9th at 1:08 pm, Officer Sutphen was patrolling in the Ticonderoga area when he noticed a plume of black smoke from an area along Black Point Road. MPO Sutphen immediately called Headquarters to dispatch Ticonderoga Fire Department to the area. Upon arriving, Officer Sutphen found a small boat with an outboard motor fully engulfed with a 5-gallon gas can also on fire. Officer Sutphen attempted to put the fire out with his fire extinguishers but was not able to. The vessel started to melt and burned to the waterline. Ticonderoga Fire was able to extinguish the fire and the boat was towed into shore. NYS Spills was notified of the incident. There were no injuries with this fire.

Personal Injury Accident: At about 6:30 pm on July 10th, Patrols were dispatched to a dock in Huddle Bay for a personal injury accident involving a PWC. Officer Webster arrived to find that a woman was a passenger on a PWC when it hit the wake from another boat. The operator and passenger were thrown from the PWC and the woman struck her head on the machine on the way off. She was dropped off at a dock and EMS was called. The operator of the PWC then left

the scene. The woman was transported to Glens Falls Hospital and later transferred to Albany Medical Center. The woman was very uncooperative with officers during their investigation into who was driving the PWC.

Late Night Call: On Saturday July 17th at approximately 2:20 am the occupants of a boat by Hecker Island by Huletts Landing dialed 911 when they drove up on rocks. Officers Webster and Andersen came back into work and arrived at the scene around 3:00 am. When they arrived, they found a family who went for a late-night ride. They went through the eye of the needle between Hewett and Hecker Islands then misjudged where they were and drove up on a shoal about 100' from Hecker Island. The boat on the rocks was anchored for the night and officers transported the family back to Sabbath Day Pt. There was only minor damage to the boat on the rocks when it was retrieved the next day.

Capsized Boat: On Wednesday July 21st, MPO Andersen was dispatched to a capsized boat on the East side of Green Island. When Andersen arrived, he found a 14' boat overturned with the occupants and camping gear in the water. MPO Andersen quickly got everyone out of the water and helped retrieve the camping gear. He then brought the overturned boat and the passengers back to shore. Everyone needs to be careful not to overload a small boat and proceed out into the main lake. Once the first wave rolls over the bow, the boat starts going down quickly.

Possible Heart Attack: On Saturday July 24th, Patrols were dispatched to Log Bay for a report of a male unconscious and breathing not confirmed. Officer Webster arrived at the scene first to find a male laying on the floor of his boat. The victim was now conscious and breathing. He was being attended to by a registered nurse and EMT from nearby boats. Officer Webster assisted at the scene until Queensbury Fire Boat could arrive to transport the victim to Glens Falls Hospital. Also assisting at the scene were Officers Mazzacano, Mitchell and Lt. Johns. It is always great to see that member of the public are willing to jump in and assist in emergencies.

Injury in Huletts: At about 2:00 pm on Sunday July 25th, MPO Kneeshaw responded to an injury on a vessel in Huletts. It appears the operator of the boat slowed quickly and a 72 yo passenger, who was standing, fell forward into the cabin striking her head on a countertop down below. Kneeshaw called ahead to have Bolton EMS meet him at the dock at Green Island and led the vessel with the injured woman in.

Possible Vessel Fire: On Wednesday July 28th, Lt. Johns responded to a possible boat fire in the area of Baldwin Dock in Ticonderoga. Upon arrival there was no vessel with signs of being on fire and Ticonderoga Fire Department was on shore. Upon further investigation, it appears that a shoreline homeowner was attempting to light a fire in a firepit with gasoline. The gas can caught fire and he panicked and through the gas can into the lake. Gas from the can leaked out and caught the surface of the water on fire. People from across the lake thought it was a boat on fire and called 911. NYS Spills was contacted by Lt. Johns. They, along with DEC Officers responded to the scene the next day to investigate. A good lesson not to use gas to light fires.

Boat on the Rocks by Diamond Island: Officer Mitchell was dispatched to Diamond Island around 5:00 pm on Friday July 30th for a boat that struck the rocks. Mitchell arrived to find that the vessel sustained extensive damage and it was towed to the dock at Diamond Island to await a tow. While at the dock, the boat sunk in shallow water. Air bags were needed to tow the boat back to shore. Officer Mitchell transported the passenger back to shore when the tow arrived.

Expensive Collision: On Thursday August 12th, Officer Knoop was dispatched to investigate a property damage accident that occurred the night before at about 10:20 pm. Knoop found that a boat was traveling through Harris Bay the previous night and struck one of Darrin Fresh Water Institute's Data Platforms that is anchored in the bay. There were marks right over the top of the platform that showed where the prop cut into it. In all, damage to the boat and the data platform exceeded \$155,000. Knoop cited the operator with operating a vessel with an expired registration.

Stranded Campers: On Monday August 16th at 11:15 pm, Patrol was called out for 2 young stranded campers on Turtle Island. It appears the 23 yo and 12 yo girls stayed on the island while their parents went to Bolton to get supplies. When the parents brought the supplies back to the marina to return to Turtle Island, they found that their small boat was leaking and they would not make it back to the island. A plan was made and the parents were to sleep in their car and the girls would stay on the island until the next morning when the parents could rent a boat to go get them. At around 11 pm, the girls became frightened by noises on the island. The parents called 911 and Officers Andersen and Webster went out to pick up the girls and their gear. The family was reunited around 12:15 am.

Rattlesnake on an Island: On Tuesday August 24th at about 7:30 pm, Officers Andersen and Rogan were called to Turtle Island for a report of a rattlesnake under a wooden platform. The officers notified DEC staff to dispatch a snake handler who has protective equipment to remove snakes from islands. Officers worked to keep people away from where the snake was and to keep an eye on the snake so they did not lose it before the handler arrived. Upon arrival at 8:45 pm, the snake handler attempted to get the snake from under the platform. The snake did not seem to want to go however. The more he tried, the further under the platform the snake went. Finally, at about 9:30 pm he was able to grab the snake and put it in a can for transport to Green Island and eventual rerelease.

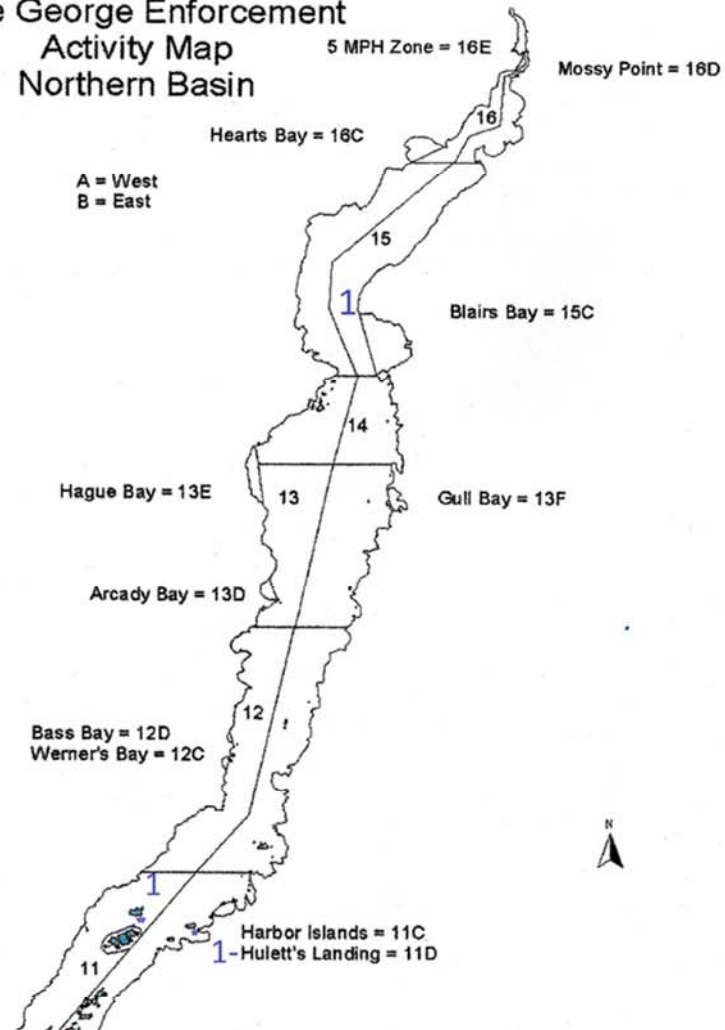

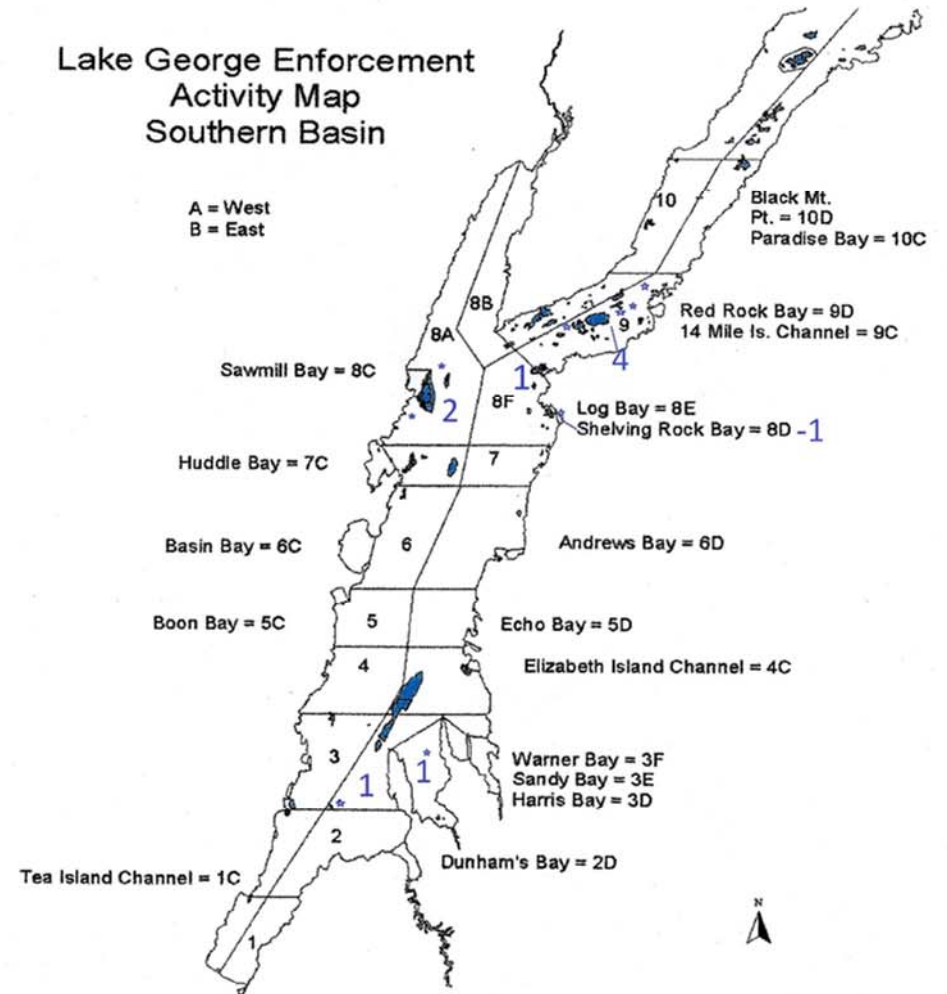

Boating While Intoxicated

In 2021, the patrol continued to focus on removing intoxicated operators from the lake. In 2021, there was 1 BWI arrest and 1 BWAI Arrest on Lake George.

Saturday July 10th East of Basin Bay: On Saturday July 10th at about 10:25pm, Officer Andersen and Lt. Johns were patrolling outside Basin Bay when they observed a vessel with no stern light. When the officers stopped the boat, there were three young men in their early twenties aboard. The operator of the boat was asked to show his registration and a form of identification. The operator seemed to move slowly and seemed somewhat confused. Officers also noticed that the operator had red glazed eyes and smelled of an alcoholic beverage. When asked if he had been drinking, the operator responded he had 1 drink with dinner earlier. After failing all the field sobriety tests administered, he was arrested for BWI. His BAC Level was 0.14%. He was processed and returned to his residence by the patrol. Assisting at the scene were Officers Sutphen and Webster who transported the boat and other passengers to shore.

Friday August 6th Just South of Dome Island: On Friday August 6th at about 9:00 pm, Officer Webster and Sgt. Paccione were patrolling in the area of Dome Island when they noticed a vessel operating without navigation lights. The vessel was stopped and while interviewing the operator, officers noticed the operator had slurred speech and smelled of an alcoholic beverage. Officers proceeded to administer field sobriety tests which the operator failed. He was transported to Green Island and his BAC Level was found to be 0.07%. He was arrested for BWAI. Officers Sutphen and Andersen assisted at the scene by transporting the boat and other passengers to shore.

With the 2 BWIs on Lake George this year, Law Enforcement kept the message out there that operating under the influence of alcohol and drugs is dangerous and will not be tolerated. While the last 2 years resulted in fewer arrests, we feel more people understand that a sober operator is the way to go.

VI. Acknowledgements

The NYS Office of Parks, Recreation and Historic Preservation has always provided the Marine Patrol with valuable training opportunities in addition to equipment and cost reimbursement through federal boater safety programs.

The Town of Lake George again donated a dock for Patrol use during the 2021 season.

The Warren County Sheriff Deputies work closely with the patrol throughout the summer. They also provide multiple training opportunities for the patrol including annual range certification.

New York State Troopers work closely with the Marine Patrol all summer and provide critical support. The State Police also do daily patrols.

The Department of Environmental Conservation's Division of Law Enforcement assists in providing support when needed.

The Department of Environmental Conservation's staff at the Green Island Maintenance Facility does an excellent job servicing and maintaining all the Marine Patrol vessels every year.

Enough can't be said about the professionalism and dedication of Lake George Park Commission's Marine Patrol Officers. The Marine Patrol has been charged with a great responsibility. They provide assistance, education and quality enforcement to all of the lake's visitors. This is a responsibility that these exceptional men take very seriously, and it shows. Year after year, positive comments regarding the Marine Patrol are both common and well deserved. They are the most visible ambassadors of the Lake George Park Commission and are directly responsible for the continued success of the Marine Patrol program.
